## **REVIEW OF PREVIOUS ITEMS**

## **Updated Open to Accrual Notice**

- Finance Specialist added as additional recipient to default Open to Accrual notification
- Update to Health Affairs library only

## **Updated Subject Deviation Notice**

- Regulatory Coordinator added as additional recipient to default Subject Deviation notification
- Update to Health Affairs and Oncology libraries only

#### **Added CHCO Research Non-Patient Site**

 Site added for CHCO to use when patients are enrolled but there is no reason to create a patient record (such as parent surveys)



## **REVIEW OF PREVIOUS ITEMS**

#### Added UCHealth Reference Lab

- Institution added to assist in billing compliance and overall study management/activation at UCHealth
- Institution will have no study site and subjects will not be registered to this institution

### **Removed SOM-Medicine Department**

 Removed to facilitate more accurate reporting of department conducting the research and should now match the department in which the PI has a faculty appointment.



## **REVIEW OF PREVIOUS ITEMS**

## **Updated Protocol Shell Notification**

- When a protocol shell is built in OnCore, submitter and additional submitter fields from HSRP submission will be notified with instruction on how to update and maintain staff tab
- Once shell is built, Regulatory coordinators and CRMs may
  - update the staff tab
  - enter IRB approval
  - begin PC Console required signoff actions



## **DEFINITIONS – CHANGES VS PROPOSALS**

#### Change

- Study team approval not required
- Will be implemented immediately
- Affected parties are notified prior to and after implementation
  - Newsletter
  - Department Advisory Meeting

#### **Proposal**

- Planned change
- Requires review and approval from one or a combination of:
  - Study Teams
  - Research Administration Staff
  - Change Control Board



## **CHANGE: HSR PORTAL – UCHEALTH QUESTIONS MOVED**

#### **UCHealth Questions Moved In HSR Portal**

 UCHealth-specific questions related to management of the study in Epic and to Clinical Services and Ancillary Services have been moved to a different survey instrument.

#### **Impact**

- This will allow submitters to submit the HSR Portal form while still seeking answers for Epic-related and UCHealth-service related questions.
- Based on the study, submitters will still be prompted to answer these
  questions if required. If required to complete, these surveys need to be
  completed prior to UCHealth issuance of approval or Open to Accrual
  in OnCore.
- The survey(s) will show in the survey queue once the HSR Portal application is submitted. Provided is an example screenshot for UCHealth Epic Facilitation survey still outstanding:





## **CHANGE: HSR PORTAL – PATIENT INTERACTION QUESTIONS**

#### **Patient Interaction Questions Replaced in HSR Portal**

 To streamline portal submissions a few questions regarding patient interaction have been updated. This will allow branching logic to function

more efficiently.

## **CHANGE: ADDED PARKVIEW MEDICAL CENTER**

#### **UCHealth – Parkview Medical Center added**

This is available as an institution & its own site in the Institutions
 Tab in the PC Console

#### **Impact**

 Future and current studies that occur at Parkview Medical center will have this institution & site listed in the PC Console



## **CHANGE: CONSENT TYPE ADDED**

#### Information Sheet/Postcard Consent added as a Consent Tpe

 Information Sheet/Postcard Consent added as a consent document type that can be uploaded to IRB Reviews.

#### **Impact**

 When updating for IRB reviews, study staff can now add the specific document type "Information Sheet/Postcard Consent" and this will also be able to be associated as a signed consent for a patient in the Subject Console.



## **CHANGE: REMOVING CANCER CENTER – OTHER DEPT**

## Cancer Center – Other Department Currently Being Removed from OnCore

 This has already been removed from the HSR Portal. It has not yet been deleted entirely from OnCore as still working through protocols that have it associated.

#### **Impact**

 This is being removed to facilitate more accurate reporting of department conducting the research and should now match the department in which the PI has a faculty appointment.



## PROPOSAL: AMENDMENT BUDGET TASK LIST

#### **Amendment Budget Task List**

 Similar to the Budget Task List in PC Console that is available at study start up, study teams have requested an amendment budget task list for amendments in order to pull metrics and track that process.

#### **Impact**

- Current plan would be for study teams to ask for this to be added to a protocol as needed and not be added by default each time there is an amendment. This is because not all amendments have budget updates and sometimes multiple amendments are processed together over time before final changes are released.
- Request by study team could be performed after they are notified of amendment MCA/calender update review.
- This would be a task list available for study teams to update and would not be actively managed by OnCore administrative staff.



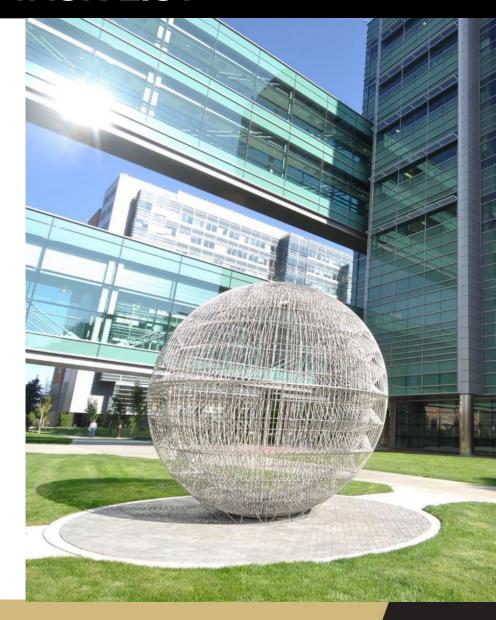
