Representative Services and Populations:

- The CU Research Pharmacy (CURP) provides services to investigators who enroll subjects in protocols requiring investigational drug dispensing or administration in the outpatient setting.

I. Protocol Initiation/Start up (one time charge)

To include:

- Protocol review and identification of pharmacy/dispensing methodology
- Staff In-services
- Initial meeting(s) with Sponsor/Investigator(s)
- Developing procedures for storage, randomization/blinding, dispensing, maintenance, and drug accountability
- Preparation of IDS budget
- Set up and build of SOP
- Vestigo build

Outpatient Standard: \$3000
(Close out will be added at the beginning of study)

Study year start date is based on the date of the sponsor study initiation visit or the date of study medication receipt.

II. Protocol Annual Maintenance (Assessed after first study year for any part of a year)

To include:

- Inventory control/accountability/record maintenance
- Ordering/receiving/storage
- Ongoing meetings with Sponsor/Monitors/Investigators
- Quality Assurance monitoring
- Collection, reconciliation & storage of returns
- Return or destruction of used or expired drug
- Protocol amendment(s)

Based on enrollment activity, monitor visits, number and extensiveness of amendments, storage needs, reporting requirements - as determined by IDS pharmacist.

\$ 3,000 annually (billed prorated monthly fee until study closeout)

III. Dispensing and Compounding Support (each study drug dispensed will have an associated dispensing fee)

Staff members preparing budgets should factor in cost increases of up to 10% per year in the event that there are price increases to CURP purchase prices. In addition, please plan for a annual 3% increase in overall CURP fees.
